Continuing Professional Development (CPD) is the means by which electrical licence holders can maintain, improve, broaden and enhance their knowledge skills and competence.

The Skills Maintenance training will be specific to every class of licence, and will be mandatory for every electrical licence held.

This course provides the mandated professional development required by Energy Safe Victoria before renewal of your Electrical Licence.

Students must complete a Short course Enrolment Form, provide Photo ID and a copy of their Electrical Licence to be enrolled in this course.
